### Terms of Sale

By signing this Contract, Adopter and Breeder agree to the following:

#### **BREEDER** (Kingdom Ragdolls, LLC):

1: Kitten(s) is healthy to the best of the breeder's knowledge, has had all age-appropriate vaccinations and deworming and is free of all internal and external parasites as confirmed by a licensed veterinarian at the time of adoption. \*Please keep in mind that young kittens may show signs of stress when brought into a new environment which may include sneezing, runny nose, watery eyes, diarrhea or constipation. These should resolve within a few days.

2: Breeder will provide a pet record from a licensed veterinarian listing all vaccinations, deworming's, treatments (if any) and the dates thus far.

3: The kitten's dam and sire were negative for feline leukemia as kittens and have not been exposed to any outside or unknown cats. The kitten's dam and sire are negative/negative for the two known HCM (hypertrophic cardiomyopathy) genes.

4: The breeder guarantees for ONE YEAR that if a fatal defect occurs as a result of a genetic or congenital defect the breeder will replace the kitten (less shipping charges and veterinary expenses). A histopathology/necropsy report (at buyer's expense) from a licensed, board-certified veterinarian is required.

5: Viral diseases (including Feline Infectious Peritonitis or FIP), parasites or bacterial infections are not covered by this health guarantee.

6: Breeder does not warranty the cat/kitten from any adverse reactions against future vaccinations or any other procedures/surgery performed on the cat/kitten including spay/neuter.

7: Due to my former business partner retiring my breeders without my knowledge, kitten(s) **can not** be registered through TICA.

8: Breeder will not release or discuss any personal information of adopter(s) with any outside parties.

# Kitten Contract and Guarantees Continued

**ADOPTER \_\_\_\_\_:**

- 1: Ragdolls cats/kittens are generally indoor cats only. However, if an adopter chooses to allow kitten(s) purchased from Kingdom Ragdolls, LLC outdoors where it may be exposed to diseases, fleas, ticks and parasites, all health guarantees shall be void.
- 2: Adopter is responsible for ALL veterinary expenses incurred after acquiring kitten(s).
- 3: After purchasing a kitten, the adopter is responsible for all future recommended routine vaccinations and deworming to maintain the health of the kitten. *\*Please discuss with your veterinarian which Rabies vaccination they recommend.*
- 4: Kittens should only be vaccinated with "killed virus" or "modified live-virus" vaccines and NOT "LIVE VIRUS" VACCINES. Adopter agrees that the kitten(s) will NOT BE VACCINATED with the feline leukemia vaccine or FVRCP and a RABIES vaccine at the same time as a potentially life-threatening reaction may occur. If FVRCP and rabies vaccine are given at the same time, this may void any health guarantees.
- 5: Adopter agrees to have the kitten spayed/neutered no earlier than 5 months of age. Confirmation of the neuter/spay from your veterinarian is required before TICA registration can be completed. If the breeder does not receive proof of the spay/neuter prior to the kitten reaching 1 year of age, breeder is not obligated to register the kitten(s) paperwork with TICA.
- 6: Adopter is responsible for any and all allergies, landlord/tenant agreements or disputes, housetraining, and behavior that may arise after taking ownership of their kitten(s).
- 7: If you should no longer be able to keep your kitten, the breeder will work with you to find a suitable home. No refunds will be issued if you are not able to keep your kitten(s). If the kitten(s) is found to have been sold or given away, the health guarantee is void and is not transferable.
- 8: Any breeding of an unaltered Kingdom Ragdolls, LLC kitten(s) without breeding rights is strictly prohibited. The Breeder may elect to proceed with legal action if it's discovered that the adopter is breeding a Kingdom Ragdolls, LLC cat/kitten without authorization. Legal proceedings will take place within the County and State of Breeder's residence.
- 9: If the adopter violates any of the terms of this contract, the breeder has the right to reclaim ownership of the kitten(s) with no refund or reimbursements.
